**ANNOUNCEMENT:
ACCEPTING APPLICATIONS FOR CAPITAL CLEMENCY REGISTRY**

The Private Court Appointed Counsel (PCAC) Screening Committee of the Eleventh Judicial Circuit is accepting applications to become an active member of the Eleventh Judicial Circuit Court's **Capital Clemency Registry**. Attorneys on the Capital Clemency Registry will be appointed by the court to represent a person convicted and sentenced to death in clemency proceedings.

Effective July 1, 2013, pursuant to 2013-216, Laws of Florida, the contracting and payment for private court-appointed attorneys representing a person in capital clemency proceedings was transferred from the Department of Corrections to the **Justice Administrative Commission**.
