- ◆ **DISSOLUTION OF MARRIAGE:** Divorce with minor children/Divorce with Property or Debts/ Divorce with no children, no property and no debts

- ◆ **MODIFICATION:** To modify any provision contained in your Final Judgment on Family and or Child-Support divisions.
Service Fee: \$85.00 Filing Fee: \$50.00 (Filing fee may or may not apply) Workshop Fee: \$80.00-\$100.00
- ◆ **PATERNITY:** To establish Paternity, Parental Responsibility, Child Support and Visitation by either parent who were never married.
Service Fee: \$85.00 Filing Fee: \$301.00 Workshop Fee: \$80.00-\$100.00
- ◆ **PETITION FOR THE DETERMINATION OF PARENTAL RESPONSIBILITY/TIME SHARING:** To establish Parental Responsibility, Parenting Plan, Time Sharing, and Visitation when Paternity has already been established through a Child-Support Order.

- ◆ **TEMPORARY CUSTODY:** To obtain temporary custody of a minor child if you are the child's brother, sister, grandparent, aunt, uncle, cousin, and or step-parent.

- ◆ **DISESTABLISH PATERNITY PACKET:** To disestablish a man's paternity, remove the man's name from a child's birth certificate and or terminate a man's child support obligation.

- ◆ **CHILD SUPPORT ENFORCEMENT:** Reinstate Driver's License/ Notice of Delinquency/Determine Arrears
Service Fee: \$45.00 Filing Fee: \$50.00 (Filing fee may or may not apply)
- ◆ **ADMINISTRATIVE SUPPORT PACKET:** When child support has been established through the Department of Revenue: 1) Appeal the Final Order. 2) Request the Circuit Court to adopt the order and enter a superseding order

- ◆ **Answer * / Counter Petition Packet:** When you need to file a response to a petition filed against you.
