

## **courtMAP Text Alerts - Terms and Conditions**

Once you have read and agree to the following Terms and Conditions and the below Privacy Notice, check the box “I agree with the Terms and Conditions”

### **Terms and Conditions**

courtMAP Text Alerts is a free platform that allows you to subscribe and sign up for SMS/text messages about upcoming court hearings in a case scheduled via courtMAP (Court Management and Access Platform).

SMS/text messages received via this platform is **NOT** the official record or notice of court event. To receive official notice, sign up [HERE](#).

All users should independently verify court event dates, times and locations by reviewing their official notice, checking with the Clerk of Court’s office as dates, times and locations may change.

I acknowledge that I must provide a valid and working mobile number to receive notifications. I confirm that I am the subscriber to the provided mobile number or that I am the customary user of that number and that I am authorized to subscribe for notifications. I understand that I will continue to receive notifications until I unsubscribe for the case you subscribed to.

I agree to receive one or more SMS/text messages from courtMAP Text Alerts containing court-related information, sent to the mobile number that I provided. I further understand that SMS/text message frequency depends upon my subscriptions and on activity on the court cases I have subscribed to.

### **I further understand that:**

- I can discontinue all future SMS/text messages from courtMAP Text Alerts using the Unsubscribe tab of the platform and entering the case number, mobile number and valid passcode.
- Standard message and data rates may apply.
- SMS/text messaging is not available in all areas and on all devices.
- Not all mobile devices or handsets may be supported.

I understand that this is a courtesy notification and not a legal notice. I also understand that the Florida State Courts System and the mobile carriers are not liable for delayed or undelivered messages.

By checking the box “I agree with the Terms and Conditions” you are agreeing to receive SMS/text messages from the courtMAP Text Alerts platform for the cases that you subscribed to. I understand that by subscribing to SMS/text messages from the courtMAP Text Alerts platform, I agree to these Terms and Conditions and Privacy Notice.
